Social issues

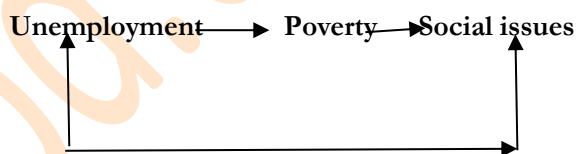
